HONORS THESIS ABSTRACT

An estimated forty percent of jail inmates suffer from chronic health problems. It is important to know what kinds of issues the corrections population faces most commonly. My project looks at the perceptions of nurses who work at a county jail in rural Indiana to see what they view as the most common inmate health problems. It also looks at literature relating to the topic, and compares the results of the two sources of information. I used a seven-question qualitative survey to ask the nurses about what they viewed as the most common problems they saw. I found that both sources mentioned chronic illness and substance use as important issues, but only the literature mentioned serious mental illness and sexually transmitted infections, while only the survey mentioned seizures, insomnia, headaches, toothaches, and urinary tract infections.

Nurses' Perceptions of Inmate Health Problems in Correctional Facilities: A Qualitative Study Overview

The health of jail and prison inmates is an important yet often overlooked issue. Jail and prison inmates are more likely than the general population to use medication, have chronic illnesses, and have infectious diseases. The methods used for this study will include a literature review as well as an internet based survey using Qualtrics. For the literature review portion, previously published statistics and articles will be examined. The survey will be qualitative in design and will use nurses who work in correctional facilities as the primary sources. Participants will be asked for demographic information in addition to the questions about perceived inmate health problems. The data gathered in the survey will be analyzed by the student and the professor for common themes. The information found in the literature review will then be compared to the information gathered during the survey (Appendix A). Results will be presented in a poster during Nursing Honors Poster Day Spring 2017 and at the American Psychiatric Nurses

Literature Review

When looking at the literature the corresponded with my study, I found several main themes related to jail inmate health. I found that persons with severe mental illness in jails have increased rates of chronic illness compared to the general population, and also that incarcerated persons have very high rates of chronic illness compared to the general population (General medical problems). I also found that the number of jail or prison inmates with mental illness is disproportionately large (Comorbid mental illness). Another important thing I found was that many jail inmates come from low resource

communities and have increased rates of unemployment, lack of health care, and lack of stable housing. Because of this, jail may be some inmates only source of health care. Conditions like tuberculosis and HIV are frequently diagnosed after routine screenings in jails (Jails as public health partners). Another reason problems may be diagnosed in jails is that inmates have the opportunity to feel pain or other symptoms that may have been masked or diminished by substance use (Prisoners perspectives). Jail inmates have high rates of chronic conditions such as asthma, diabetes, hypertension, HIV, tuberculosis, hepatitis, and mental illness. Also, approximately 65% of jail inmates need treatment for a substance use disorder (The critical link).

Survey

To make and distribute my survey, I first had to get approval from the IRB at Northern Illinois University. Then, I contacted the nursing director at the jail I wanted to work with. She agreed to distribute the survey to her employees. Dr. Hickey and I sent out a recruitment letter (Appendix B) along with our seven-question qualitative survey (Appendix C). We had a 100% response rate from the nurses that the survey was distributed to.

When looking at the responses, it was easy to see some common themes.

Substance use and addiction were mentioned by almost 100% of responders. Other common problems mentioned by the nurses included urinary tract infection, headache, toothache, insomnia, and seizures.

When comparing the results of the literature review and the survey, we found that substance use and chronic conditions (MRSA, hypertension, diabetes, asthma, chronic pain) were identified as important problems by the nurses and the literature. Only the

literature mentioned tuberculosis, HIV, sexually transmitted infections, and serious mental illness. Only the survey results included headache, toothache, insomnia, seizures, and urinary tract infections.

Because only six nurses were surveyed for this project, it should be repeated on a larger scale that includes more diverse locations.

After finishing the survey, I made my poster (Appendix D) and applied for it to be presented at the APNA conference, where it was accepted to be presented in poster form.

I also presented it at the School of Nursing Honors Poster Day.

Objective

My honors capstone project will focus on health problems that are common among prisoners. I will be looking at research that has been done on this topic as well as surveying nurses who work in correctional facilities to see what their perceptions of the most prevalent health problems are. - Both identified chronic conditions and substance use as important themes

Future Implications:

Because only 6 nurses were surveyed for this study, it should be repeated on a larger scale in the future. It should also be repeated in alternate settings since the nurses in this study worked in a rural Indiana setting.
